
Instructions:

General Requirements

- 1. The entire cost of the driveway/culvert construction shall be the obligation of the applicant.
- 2. The applicant, his successor, or assignee agrees to hold harmless the Town of Washington, its agents and employees, against any action for personal injury or property damage sustained by reason or exercise of this permit.
- 3. The applicant shall make the installation without jeopardy to or interference with traffic using the roadway.
- 4. Fill shall be made over culverts so that culvert ends are free and the ends shall be riprapped or sodded to prevent fill material from spilling into the ditch and plugging the culvert.
- 5. The driveway shall be designed and constructed in such a manner to prevent erosion and runoff of soil and gravel onto the town roadway.
- 6. The applicant shall keep the driveway culvert free of debris and other obstructions in order to provide proper drainage along the roadway.
- 7. Maintenance and upkeep of the driveway and culvert in the Town right-of-way shall be the responsibility of the applicant.
- 8. If at a later date the Town of Washington Highway Department deems it necessary to have a culvert at this entrance, this will be done at the Highway Department's request and at the owner's expense.
- 9. Roadway surfaces, shoulders, ditches and vegetation disturbed shall be restored to equivalent or original condition by the applicant.
- 10. The applicant is responsible for damage to the road edge caused by construction.
- 11. The driveway shall be designed and constructed to provide adequate access for emergency vehicles.
- 12. Work shall be carried out in a manner satisfactory to the Town of Washington Highway Department and in compliance with the requirements of this permit.
